Dear Parent/Carer

Year 7 and Year 8 Visit to Côte d'Opale, France 2018

I am very pleased to inform you that I have secured a provisional booking with European Study Tours (EST) at the Village Vacances at Stella Maris for 2 nights from Friday 6 – Sunday 8 July 2018. This visit is subject to governor approval but approval for previous visits has always been given. Breakfast and an evening meal will be served at the centre with a packed lunch being provided for midday. All dietary needs can be accommodated. Travel will be by executive air-conditioned coach via the ferry (outward) and Eurotunnel (inward). We will travel on a Group Passport, which is included in the cost, as is insurance. Students will need a small amount of pocket money; we estimate that 30 – 40 euros should be sufficient. I have provisionally booked 40 places and the cost of this visit, based on 45 students, is £310 per student.

The Côte d'Opale is an area that offers visitors many opportunities to explore several aspects of French culture and history. We will leave very early on the morning of Friday 6 July and look to return mid-evening on Sunday 8 July. Our proposed itinerary includes the Becasuc sweet factory, the traditional Saturday morning market at Le Touquet, a visit of Old Boulogne, The Agincourt Medieval Museum and the La Coupole Memorial Museum (WW2 Rocket Factory) and Planetarium Cinema Experience where visitors can learn about the German rocket programme and its significance in the development of space exploration. There may also be the opportunity to take in a Hypermarket but this will depend on time being available. There will also be a full programme of evening activities to ensure there is no time to be bored or homesick: sand castle contest, 5-a-side football, boules, charades, parlour games and quizzes have all featured in the past.

We would wish to reassure parents that we have reviewed the itinerary in the light of current advice from the Foreign and Commonwealth Office. During outdoor visits students will remain with their designated teacher with a ratio of 1:8. We believe that the assessed risks are, on balance, no greater than they would be on a residential visit in the UK and the current FCO advice supports this view.

Early applications are most likely to be successful. In the event of over-subscription priority will be given to students who will not have the opportunity to go next year and we will also hold a reserve list. However, the school reserves the right to withdraw a place from any student whose behaviour record suggests that he might present an unacceptable risk to the safety and enjoyment of other members of the party.

Under the terms of current educational legislation, the cost of this visit can only be raised through voluntary contributions and if there are insufficient voluntary contributions the visit will not be able to go ahead. Applications should be returned no later than **Wednesday 14 March** but <u>DO NOT SEND ANY PAYMENT AT THIS STAGE</u>. Once your place has been confirmed the visit will appear on your ParentPay account and you will need to pay a £75 deposit by Friday 23 March. Interim payments can be made if so desired but the final balance of £235 will be due by Friday 27 April. Once paid to EST, deposits are non-refundable; however, in the event that we are unable to offer applicants a place, deposits would be returned. If deposits are not paid within the above timeframe we reserve the right to offer the place to a student on the reserve list. If meeting these payment dates is a problem please contact me to discuss if alternative arrangements are possible.

Last year's visit proved to be a resounding success and we look forward to offering your son this opportunity. Please do not hesitate to contact me if you have any queries regarding this visit.
